STATEMENT ON RULES OF DECORUM AND ENFORCEMENT

The Brown Act provides that members of the public have a right to attend public meetings, to provide public comment on action items and under the public forum section of the agenda, and to criticize the policies, procedures, or services of the city or of the acts or omissions of the city council. The Brown Act also provides that the City Council has the right to exclude all persons who willfully cause a disruption of a meeting so that it cannot be conducted in an orderly fashion.

During a meeting of the Orange Cove City Council, there is a need for civility and expedition in the carrying out of public business in order to ensure that the public has a full opportunity to be heard and that the Council has an opportunity to conduct business in an orderly manner. The following is provided to place everyone on notice of the rules of decorum and enforcement.

GENERAL RULES OF DECORUM

While any meeting of the City Council is in session, the following rules of decorum shall be observed:

- 1. All remarks shall be addressed to the City Council as a whole and not to any single member, unless in response to a question from a member of the City Council.
- 2. A person who addresses the City Council under public comment for a specific agenda item or under the Public Forum section of the agenda may not engage in speech or conduct (i) which is likely to provoke others to violent or riotous behavior, (ii) which disturbs the peace of the meeting by loud and unreasonable noise, (iii) which is irrelevant or repetitive, or (iv) which disrupts, disturbs, or otherwise impedes the orderly conduct of any City Council meeting.
- 3. A person, other than members of the Council and the person, who has the floor, shall not be permitted to enter into the discussion unless requested by the Mayor to speak.
- 4. Members of the City Council may not interrupt a person who has the floor and is making public comments. Members of the City Council shall wait until a person completes his or her public comments before asking questions or commenting. The Mayor shall then ask Councilmembers if they have comments or questions.
- 5. No person in the audience at a Council meeting shall engage in disorderly or boisterous conduct, including the utterance of loud, threatening or abusive language, whistling, stamping of feet or other acts which disturb, disrupt or otherwise impede the orderly conduct of any Council meeting.

ENFORCEMENT OF DECORUM RULES

(Resolution No. 2012-16)

While the City Council is in session, all persons must preserve order and decorum. A person who addresses the City council under public comment for a specific agenda item or under the Public Forum section of the agenda may not engage in speech or conduct which is likely to provoke others to violent or riotous behavior, which disturbs the peace of the meeting by loud and unreasonable noise, which is irrelevant or repetitive, or which disrupts, disturbs, or otherwise impedes the orderly conduct of any City Council meeting.

The Mayor or other presiding officer shall request that a person who is breaching the rules of decorum cease such conduct. If after receiving such a warning, the person persists in breaching the rules of decorum, the Mayor or other presiding officer may order the person to leave the City Council meeting. If such person does not leave, the Mayor or presiding officer may request any law enforcement officer who is on duty at the meeting as sergeant-at-arms to remove the person from the Council Chambers. In the event there is no one from law enforcement present, the Mayor or presiding officer may direct the City Manager to contact law enforcement.

In accordance with the Point of Order Rule 4.6, the majority of the Council may overrule the Mayor if the majority of the Council believes the Mayor or other presiding officer is not applying the rules of decorum appropriately.

RECOMMENDATION:

Council adopt the attached resolution accepting the bid from Grizzly Construction for the installation of a pressure relief valve and appurtenances for \$16,900 and authorize the City Manager to sign a standard construction agreement.

EXECUTIVE SUMMARY:

The Orange Cove High School uses untreated water from the Friant-Kern Canal for landscape irrigation. The pipeline from the canal to the high school is owned by the city. The pipeline has a history of leaking due to pressure spikes caused by the high school irrigation valves closing quickly. This project will install a pressure relief valve on the pipeline to allow the pressure to be vented to the atmosphere. The bid for the work is \$16,900.

BACKGROUND:

The city owns an irrigation pipeline from the Friant-Kern Canal to the Wastewater Treatment Plant. This pipeline originally conveyed tertiary-treated effluent from the WWTP to Orange Cove Irrigation District distribution system. This pipeline has been used since the Orange Cove High School was constructed as their supply for irrigation water. The arrangement reduces the demand on the city's water treatment plant.

The High School is the only user on the line now, but the new soccer field at Feinstein Park will also use this same pipeline for supply. When the irrigation equipment shuts off, the water moving in the pipeline continues to move and creates a water hammer and pressure spikes. Connection on the irrigation pipeline for vacuum and air release valves are the weakest point and have failed repeatedly requiring repairs.

This project will install a pressure relief valve on the pipeline to alleviate the pressure spikes and protect the fittings along the pipeline. Bids were solicited from 3 contractors and only one submitted a bid. Grizzly Construction submitted a bid of \$16,900. Our engineer's estimate was \$15,000. We have worked with Grizzly Construction on other projects and know them to be a reputable contractor. Although only one bid was submitted, the contractor did not know that he would be the only bidder at the time he prepared his bid.

Funding for the project will come from the Water Fund.

REASON FOR RECOMMENDATION:

Grizzly submitted the low bid of \$16,900.

FISCAL IMPACT:

The Water Fund will expend \$16,900 for the project.

ALTERNATIVES:

The Council may reject the bid.

A RESOLUTION OF THE COUNCIL OF THE CITY OF ORANGE COVE, CALIFORNIA, ACCEPTING BID FOR THE HIGH SCHOOL PRESSURE RELIEF VALVE

WHEREAS, the City of Orange Cove owns and operates an irrigation pipeline along Parlier Avenue from the Friant-Kern Canal to the Wastewater Treatment Plant; and

WHEREAS, the pipeline is used by the Orange Cove High School for landscape irrigation and the pipeline needs a pressure relief valve to reduce breaks in the pipeline caused by pressure spikes due to rapid valve closing; and

WHEREAS, bids were solicited from three contractors to install a pressure relief valve on the City's irrigation pipeline and only one bid was submitted by Grizzly Construction, Inc. for \$16,900 on January 27, 2017.

NOW, THEREFORE BE IT RESOLVED, by the City Council of the City of Orange Cove, California, as follows:

- 1. The above recitals are true and correct and are adopted as the findings of the City Council.
- Upon recommendation of the City Engineer the bid from Grizzly Construction, Inc. for Sixteen Thousand Nine Hundred Dollars and No Cents (\$16,900.00) is hereby awarded for the High School Pressure Relief Valve Project.
- 3. The City Manager is authorized to sign a standard construction agreement with Grizzly Construction, Inc. for the work.
- 4. The provisions of this Resolution are severable and if any provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, sections, words or parts thereof of the Resolution or their applicability to other persons or circumstances.
- 5. That the City Clerk shall certify to the adoption of this Resolution and that the same shall be in full force and effect.
